ATTENDANCE LEVELS AND VISITORS.

There have been many members who have not made any attendances during 2021 and have not made the Committee aware of any reasons. The range has been open for approximately $\frac{3}{4}$ of the year including both Sunday and mid-week meets. The Committee understands that the current times are difficult, but it has put procedures in places to ensure the health & safety of those attending. If you have not made any attendances and have not been in touch with the club Secretary, either through another member or a Committee member, with reasons, you may not be sent an invitation to renew your membership until you do contact the club. You should also already be aware of the requirement for the club to comply with Home Office rules by providing details of any member who has not attended for any 12 month period, this is not Jan-Dec but any 12 month period. **VISITORS:** The fee for Visitors has been set at £3 for many years, despite the subscriptions having risen several times. The Committee has therefore decided to increase the fee to £5. All visitors must satisfy the current legal requirements to visit, such as Full member of a Home Office approved club AND a current firearm certificate, and all visitors will be supervised and monitored for safety. The new fee will apply immediately.
